**QUALIFICATIONS** Candidates filing a nominating petition for board membership must meet the following qualifications:

- A citizen of the United States of America.
- At least 18 (eighteen) years of age to qualify for office.
- Able to read and write.
- A resident of the municipality from which he/she is to be elected for at least one year preceding the date of the election.
- Not disqualified as a voter pursuant to N.J.S.A. 19:4-1.
- A registered voter in the district
- Not disqualified from membership for the conviction of crimes pursuant to N.J.S. 18A:12-1\*\*

**No board of education member shall be directly or indirectly involved in any contract with or claim against the board.**

**IMPORTANT INFORMATION**

- \*\* Within 30 days of election or appointment to the board, a member must undergo a **criminal history background investigation** through the New Jersey Department of Education.
- The School Ethics Act and nepotism legislation impact the ability of the Board members who have relatives working in the school district to act in areas such as personnel and collective negotiations. Please consult your board secretary for details.
- Two or more candidates for any given term of office may notify the county clerk, at least seven days before the drawing date that they wish to have their names with the chosen designation, if any, bracketed together, so that their names and designation, if any, are selected as a group at the drawing and their names and designation are printed together on the ballot. The candidates determine among themselves the order in which their names are to appear within the bracket prior to notifying the County Clerk.
