In accordance with New Jersey State Regulations and the School District's Integrated Pest Management (IPM) Policy, we hereby provide the following advanced notification.

On Monday 11/07/2022 the Board of Education has scheduled a pest control application to the outside grounds. The reason for this application of pest control products is fertilization.

Should the original application date be canceled the alternate dates are the follow 11/09/22 or 11/12/2022

The specific location(s) are as follows: Monroe Township Middle School Athletic Fields and Common Grounds, Oak Tree Elementary Baseball and Softball ONLY and Monroe Township High School Common Grounds. Herbicides are only applied when they are necessary to maintain or protect the health of the school property and reduce risks of injury. Sanitation, as well as physical and biological control measures, should be considered as a part of a good integrated pest management program. Pesticides may be used as another part of a good pest control program. Herbicides are chemical substances used to control living organisms and vary in degree of toxicity. **The United States Environmental Protection Agency (EPA) and the New Jersey Department of Environmental Protection (DEP) register herbicide to determine that the use of a herbicide in accordance with instructions printed on the label does not pose an unreasonable risk to human health and the environment.** Nevertheless, the EPA and DEP cannot guarantee that registered herbicides do not pose any risk to human health, thus unnecessary exposure to herbicides should be avoided. The EPA has issued the statement that where possible, persons who are potentially sensitive, such as pregnant women, infants and children, should avoid unnecessary herbicide exposure."

All treated areas will be posted 72 hours prior to any pest control applications to the outside grounds. This is an informative posting and contains similar information to this letter. Posting signs will remain on the premises 72 hours after the application. There shall be a 7- hour reentry period, in which all persons shall remain off the treated areas.

4. First-aid measures

5. Fire-fighting measures

Methods and materials for containment and cleaning up Stop the flow of material, if this is without risk. Prevent entry into waterways, sewer, basements or confined areas. Avoid dust formation. Sweep up or vacuum up spillage and collect in suitable container for disposal. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. After removal flush contaminated area thoroughly with water.

Never return spills to original containers for re-use.

Environmental precautions Prevent further leakage or spillage if safe to do so. Do not contaminate water. Do not allow to enter drains, sewers or watercourses.

7. Handling and storage

Precautions for safe handling Keep away from all ignition sources including heat, sparks and flame. Minimize dust generation and accumulation. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Provide adequate precautions, such as electrical grounding and bonding, or inert atmospheres. Avoid inhalation of dust and contact with skin and eyes. Use only with adequate ventilation. Observe good industrial hygiene practices.
