Re: Annual Re-Notification Required By AHERA

Date: September 1, 2023

The Asbestos Hazard Emergency Response Act (AHERA) 40 CFR 763 requires all schools from Pre-K to Grade 12 to conduct inspections to determine if they contain asbestos containing building materials (ACBM). If so, an Asbestos Management Plan must be developed in which the ACBM must be categorized according to type, locations, current condition, and its potential for future damage. The Management Plan details the inspection findings, and outlines the response actions the School Board intends to implement.

To accomplish these goals, the School Board has on file at each school and in the District Offices a NJ State Department of Health approved Asbestos Management Plan for all school facilities. 3-Year Re-Inspections were completed in January 2021 and are on file as well as the most recent 6 month Periodic Surveillance. The provisions of the plan are being implemented in a timely and on-going fashion. It is Monroe Township Board of Education's desire to provide a safe and healthy facility for all students, employees, and visitors.
