# What is Title I?

**Title I provides financial assistance to states and school districts to meet the needs of educationally at-risk students**

## **Goals of Title I:**

- ▶ **Increase academic achievement**
- ▶ **Provide additional instructional services & activities to support students**
- ▶ **Provide professional development for teachers and staff**
- ▶ **Promote family engagement**

# Title 1 Eligibility

- Schools with 40% or more free and reduced lunch students can have a school-wide program with access for all
- Schools with 20 to 39% free and reduced lunch students must have a targeted program supporting students who are failing or in danger of not meeting state standards for their grade level.
- Although school eligibility for Title I funding is determined by percentage of free and reduced lunch students, eligibility for services is determined by academic need.

# Title I Support

- Supplemental services in the areas of Language Arts and/or Mathematics
- Research based intervention literacy programs
- Push-in intervention programs
- Summer Enrichment (Jump Start Freshman Program)
- Staff Professional Development

# Home Support & Family Engagement

- Show your child you support his or her education
- Check in with your child about homework and monitor Genesis Parent Portal to view grades
- Monitor attendance
- Promote positive use of free time & read with your child on a regular basis
- Attend parent-teacher conferences and school events
- Communicate with your child's teacher and/or counselor
  - Inform teacher of events that may affect performance at school
